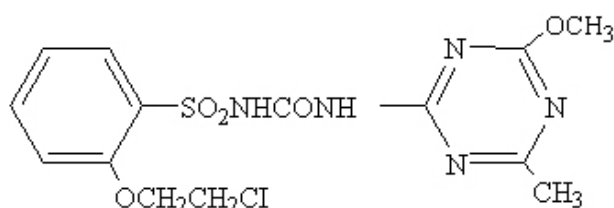

3. Hazards Identification

Toxicity: This product is unlikely to present a hazard during normal use (WHO Hazard Class III).

Poisoning symptoms: No case of human poisoning due to this product is on record. The poisoning symptoms observed with both active constituents in laboratory mammals were non-specific.

4. First Aid Measures

In case of poisoning by any exposure route contact a doctor or Poisons Information Centre.

Swallowed: Do not induce vomiting. Give a glass of water. Note: Never give anything by mouth to an unconscious person.

Eye: Flush with large quantities of clean tap water for 15 minutes. Get to a doctor.

Skin: Remove contaminated clothing and wash affected areas thoroughly with soap and water.

Inhaled: Move person to fresh air and keep at rest until recovered.

5. Fire-Fighting Measures

Use dry chemical, foam or CO₂ extinguishing media. Wear full protective clothing and self-contained breathing apparatus. Evacuate nonessential personnel from the area to prevent human exposure to fire, smoke, fumes or products of combustion. Prevent use of contaminated buildings, area, and equipment until decontaminated. Water runoff can cause environmental damage. If water is used to fight fire, dike and collect runoff.

6. Accidental Release Measures

Control the spill at its source. Contain the spill to prevent from spreading or contaminating soil or from entering sewage and drainage systems or any body of water. Clean up spills immediately, observing precautions outlined in Section 8. Sweep up material and place in a compatible disposal container. Scrub area with hard water detergent. Pick up wash liquid with additional absorbent and place into compatible disposal container. Once all material is cleaned up and placed in a disposal container, seal container and arrange for disposition.

7. Handling and Storage

Store the material in a well-ventilated, secure area out of reach of children and domestic animals. Do not store food, beverages or tobacco products in the storage area. Prevent eating, drinking, tobacco use, and cosmetic application in areas where there is a potential for exposure to the material. Wash thoroughly with soap and water after handling.

8. Exposure Controls/Personal Protection

Engineering Controls: No special requirements. Product is used outdoors.

Personal Protection: Wash hands after use.

Personal Protective Equipment:

To avoid eye and skin contact, wearing the following personal protective clothing and equipment is recommended:

Eyes: Safety goggles or face shield

Clothing: Cotton overalls buttoned to the neck and wrist and a washable hat.

Gloves: Elbow length PVC gloves.

Respiratory: Respiratory protection is not normally required. If airborne concentrations are likely to exceed the exposure standard above, an

AS/NZS 1715/1716 approved respirator should be worn.

Other: After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use wash gloves, goggles or face shield and contaminated clothing.
